°Retention of data

Your data collected will be retained, as from their receipt/update, for the purposes indicated above and in accordance with the provisions of the regulations in force and, in the event of legal disputes, for the entire duration of the same until the time limits for appeals are exhausted. In the event of processing based on consent, your data will be processed until you revoke your consent and, thereafter, for the time strictly necessary to fulfil applicable legal or regulatory and, in any case, for the time necessary to ensure the exercise of your rights, including in court.
